ADMISSION GUIDELINES FOR ANM, GNM, NPME, POST-CERTIFICATE DIPLOMA COURSES, AND LHV PROGRAMME – ACADEMIC YEAR 2025–26

A) General instructions:

1. Academic year for GNM, ANM, LHV, NPME, and Post-Certificate Courses Will Commence as per Indian Nursing Council Notification.
2. The students should be admitted and enrolled online on MSBNPE Student enrollment Portal . The username and password should be preserved by permanent and responsible staff of the institution.
3. The admission enrollment will be online and offline verified in the office of the MSBNPE. The Offline verification schedule will be displayed on MSBNPE website. Admission will be considered valid only after approval by the MSBNPE.
4. Admission of Male Candidates should be 30% of the sanctioned intake of the students as per INC norms.
5. Age criteria for admission of ANM and GNM candidates are as per INC admission criteria for A.Y. **2025-26**.
6. Check MSBNPE website- www.msbnpe.org frequently.
7. Maintain all the records and reports as per the INC norms.
8. For ANM, GNM, LHV, NPME, and Post-Certificate Courses there should be minimum 50% candidates admitted for the courses as per intake strength sanctioned by MSBNPE.
9. Institutions affiliated with MSBNPE should complete the online affiliation process within the stipulated time and pay the yearly affiliation fees as prescribed by MSBNPE. (Online payment Gateway)
10. Inspection fees, if due, should be paid as per the revised circular issued by MSBNPE (1212/2025 Dated 06/03/2025).
11. Students Patient Ratio of 1:3 should be maintained as per INC norms.
12. Enrolled students final list should be sent by institute to MSBNPE through enrollment3msbnpe2021@gmail.com on 30th September 2025 on or before till 12.00 midnight.

B) Teachers Criteria

1. All appointed Principal and Teachers should fulfill INC criteria.
2. Enrolled Teachers must have MNC Registration Certificate with updated renewal.
3. 1:10 Teachers: Students Ratio should be maintained.
4. Enrolled Teachers with MSBNPE for the said Academic Year should complete their tenure with the enrolled Institution for that Academic Year.
5. All enrolled Teachers must be registered in the **Nursing Registration and Tracking System (NRTS)** of the Indian Nursing Council and possess a valid **Live Register ID**.
6. Enrolled Teachers shall not be permitted to work in any other Nursing Institute during the said Academic Year.

NOTE: - Simultaneous attendance in any other course is not permitted.

I. ANM ADMISSION CRITERIA FOR A.Y.2025-26

AGE:

- Minimum 17 yrs (As on or before 31st December 2025)
- No Maximum/Upper age limit as per INC (circular No.-11/23 dated 21 August 2023).

EDUCATION:

- Candidates should have passed the HSC Examination (10+2) with English, securing a minimum of 40% marks in the qualifying examination conducted by the Maharashtra State Board of Secondary and Higher Secondary Education or passing out from a recognized board under AISSCE / CBSE / ICSE / SSCE / HSCE or any other equivalent board, with any stream (Science / Arts / Commerce), preferably Science.
- 10+2 with English and 40% marks in the Vocational Stream – Health Care Science, including the following subjects, shall also be eligible:
 1. **Medical laboratory technology** (Laboratory Machine (clinical Pathology, Haematology&Histopathology), Clinical Biochemistry, Microbiology)
 2. **Yoga Anatomy and Physiology,**
 3. **X-RAY Technician** (Radiation Physics, Radiography (General), Radiography II,
 4. **Ophthalmic techniques** (Special investigation, imaging & Radiograph (from a recognized CBSE board/Centre)
(Ref: INC Circular No. F.NO.1-6/SNRC/2025-INC (71324), dated 24/02/2025)
- Candidates are also eligible if qualified from the State open School recognized by State Government and National Institute of Open School (NIOS) recognized by the Central Government.

RESERVATIONS:

- It is mandatory to follow Indian Constitution Act for Reservation.
- For Disabled Candidates 5% Disability reservation is considered.
- For Admission with disability of locomotors with the tune of 40% to 50% of the lower extremities as per certified by Competent Government authority. (Refer INC circular no. F NO 1-5/2018/INC dated: 19/04/2019).
- 5% Relaxation for Reserved Category.

GENERAL CRITERIA:

- Only Female candidates are eligible for this course.
- Students shall be Medically Fit.
- Students shall be admitted once in year.
- Maharashtra State Domicile Certificate
- Admission of the Candidates shall be as per sanctioned strength mentioned in EC/GR.
- Each institute must ensure admission of a minimum of 50% of the total sanctioned intake capacity.
- Merit List should be prepared by the institute for enrolling the ANM students.

❖ **Principal should inform the students that admission will be confirmed only after verification of original documents by MSBNPE.**

II. GNM ADMISSION CRITERIA FOR A.Y. 2025-26

AGE:

- Minimum 17years (As on or before 31st December 2025)
- No Maximum/Upper age limit (as per INC circular No.-11/23 dated 21 August 2023)
- No age bar for ANM to GNM Candidates.

EDUCATION:

- Candidates should have passed the HSC Examination (10+2) with English, securing a minimum of 40% marks in the qualifying examination conducted by the Maharashtra State Board of Secondary and Higher Secondary Education or passing out from a recognized board under AISSCE / CBSE / ICSE / SSCE / HSCE or any other equivalent board, with any stream (Science / Arts / Commerce), preferably Science.
- 10+2 with English and 40% marks in the Vocational Stream – Health Care Science, including the following subjects, shall also be eligible:
 1. **Medical laboratory technology** (Laboratory Machine (clinical Pathology, Haematology&Histopathology), Clinical Biochemistry, Microbiology)
 2. **Yoga Anatomy and Physiology,**
 3. **X-RAY Technician** (Radiation Physics, Radiography (General), Radiography II,
 4. **Ophthalmic techniques** (Special investigation, imaging & Radiograph (from a recognized CBSE board/Centre)(Ref: INC Circular No. F.NO.1-6/SNRC/2025-INC (71324), dated 24/02/2025)
- Candidates are also eligible if qualified from the State open School recognized by State Government and National Institute of Open School (NIOS) recognized by the Central Government.
- Registered ANM with 10+2 qualification.

RESERVATIONS:

- It is mandatory to follow Indian Constitution Act for Reservation.
For Disabled Candidates 5% Disability reservation is considered; with disability of locomotors with the tune of 40% to 50% of the lower extremities as per certified by Competent Government authority (Refer INC circular No. F NO 1-5/2018/INC dated: 19/04/2019).
- Male candidates' enrollment should not exceed than 30% of total enrollment.
- For Orphan candidates with 1% Reservation (competent authority certificate is must)
- 5% Relaxation for Reserved Category.

OTHER CRITERIA:

- Students should be Medically Fit
- Students shall be admitted once in a year.
- Maharashtra State Domicile Certificate
- Admission of the Candidates shall be as per sanctioned strength mentioned in EC/GR.
- Each institute must ensure admission of a minimum of 50% of the total sanctioned intake capacity.
- Merit List should be prepared by the institute for enrolling the GNM students.

For Foreign Nationals & Indian Nationals Candidates:

- The entry qualification Equivalent i.e. HSC (10+2) will be obtained by ASSOCIATION OF INDIAN UNIVERSITIES, New Delhi.

- The institution and the respective State Nursing Council shall be responsible for ensuring that the candidate's qualification and eligibility are equivalent to the prescribed criteria.

- ❖ **Principal should inform the students that admission will be confirmed only after verification of original documents by MSBNPE.**

Admission to LHV, Post-Certificate Diploma, and NPME courses shall be conducted at the institute level as per the eligibility criteria and guidelines prescribed by the Indian Nursing Council (INC).

7. Equivalence Certificate (to be obtained from Association of Indian Universities, New Delhi, if student have not appeared 10+2 from recognized state board or Open Board)
