ELIGIBILITY CRITERIA FOR ANM /GNM ADMISSION

GENERAL INSTRUCTION

- 1. Academic year for ANM, GNM, Post certificate courses, LHV will commence from as per Indian Nursing Council F No 1-6/(LT)-2023-INC Dated 13th April 2023.
- 2. The student should be admitted and enrolled online on MSBNPE website. The username and password should be preserved by a permanent responsible staff of your school.
- 3. The admission enrollment will be physically verified in the office of MSBNPE on the basis of prior fixed appointment. The appointment dates will be display on MSBNPE website. The principal of respective college will report to the MSBNPE office for the same. Admission will be considered valid only after approval form the MSBNPE office.
- 4. Teaching
 - A. Staff Principal and all appointed teachers should be eligible qualified experienced as per INC norms & should be registered with MNC before their appointment.
 - B. 1: 10 Teacher: student ratio should be maintained.
 - C. Tutors should not leave the institutions during the academic year.
- 5. The authorities of the institution should not admit Male candidates for GNM Course more than 30% of the sanction intake of students per year.
- 6. Do not admit underage or overage students.
- 7. Check MSBNPE Website www.msbnpe.org on Regular Basis.
- 8. Maintain all the records and reports as per the norms.
- 9. Submit the clinical permission letter of affiliated hospital, urban public health and rural public Health posting for A.Y. 2023 – 24 before 30st Sept 2023 as prerequisite for online Enrollment.
- 10. The institution who are affiliated with MSBNPE should pay yearly affiliated fees as per the notification display on the MSBNPE website. Thereafter penalty will be charged.
- 11. Inspection fees if due should be paid as per MSBNPE circular Displayed on Board Website by payment to gateway.
- 12. Any issue regarding the exam should be personally brought to the notice of the MSBNPE office Examination section two months prior to the examination date.
- 13. Carefully mention the gender titles against the male and female candidates. No alteration/ Changes will be permitted by the office after enrollment.
- 14. Student patient ratio 1: 3 should be maintained.
- 15. For oral practical examination one examiner should compulsory be female with minimum 3yrs of teaching experience.
- 16. For examination candidates seat numbers will be uploaded on MSBNPE website. After Allotment of seat numbers, you have to complete the online Internal assessment marks as per guidelines of exam department, else MSBNPE will not be able to issue the hall tickets to the candidates. The internal assessment marks should be enter term wise as per instruction, from examination department.
- 17. During admission, enrollment students passport size photograph (2"x 2") should be scanned and uploaded, so that the photos can be printed on the hall tickets
