GUIDELINES FOR ANM, GNM, POST-CERTIFICATE DIPLOMA COURSES AND LHV PROGRAMME TO BE CONDUCTED IN A.Y. 2024-25

A) General Instructions:

- Academic year for GNM, ANM, LHV, and Post-Certificate Courses will commence as per Indian Nursing Council Notification.
- 2. The students should be admitted and enrolled online on MSBNPE website. The username and password should be preserved by permanent and responsible staff of the institution.
- The admission enrollment will be online and offline verified in the office of the MSBNPE.
 The Offline verification schedule will be displayed on MSBNPE website.
 Admission will be considered valid only after approval by the MSBNPE.
- 4. Admission of Male Candidates should be 30% of the sanctioned intake of the students as per INC norms.
- 5. Age criteria for admission of ANM and GNM candidates are as per INC admission criteria for A.Y. 2024-25.
- Check MSBNPE website- www.msbnpe.org frequently.
- 7. Maintain all the records and reports as per the INC norms of this course.
- 8. For ANM, GNM, LHV, Post- Certificate Courses there should be minimum 50% candidates admitted for the courses as per intake strength sanctioned by MSBNPE.
- 9. The institutions who are affiliated with MSBNPE should complete online Affiliation process within stipulated time and pay yearly Affiliation Fees by NEFT/RTGS.
- 10. Inspection fees if due should be paid as per MSBNPE ACT.
- 11. Students Patient Ratio of 1:3 should be maintained as per INC norms.

B) Teachers Criteria:

- 1. All appointed Principal and Teachers should fulfill INC criteria.
- 2. Enrolled Teachers must have MNC Registration Certificate with updated renewal.
- 3. 1:10 Teacher: Students Ratio should be maintained.
- 4. Enrolled Teachers with MSBNPE for the said Academic Year should complete their tenure With the enrolled Institution for that Academic Year.

ANM ADMISSION CRITERIA for A.Y. 2024-25

AGE:

- Minimum 17yrs (As on or before 31st December 2024)
- No Maximum/Upper age limit bar as per INC circular -11/23 dated 21August 2023.

EDUCATION:

- Candidates should have passed in HSC Examination (10+2) with English and
 must have obtained a minimum of 40% at qualifying examination conducted by
 Maharashtra State Board of Secondary and Higher Secondary Education or
 Equivalent, with any stream (Science/Arts/Commerce) and Vocational stream.
- Students qualified in 10+2 Arts or Science examination conducted by National Open School.

RESERVATIONS:

- It is mandatory to follow Indian Constitution Act for Reservation.
- For Disabled Candidates 5% Disability reservation is considered.

- 10+2 with English having 40% of marks in vocational Stream-Health Care Science (including medical laboratory technician, Radiology Technician, Child Healthcare services, Old Age Health Care services, ophthalmic technicians) from a recognized CBSE board/Centre.
- Candidates are also eligible from State open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government.
- · Registered ANM with pass mark.

RESERVATIONS:
