6. GNM/ANM/Post Basic Certificate School/colleges/institute were not affiliated with MSBNPE for A.Y. 2018-19, should not admit the students for A.Y. 2019-20
7. The ANM/GNM institution who has not paid Affiliation fees as per circular dated 06/03/2019 displayed on MSBNPE website, kindly pay the fees and upload the transaction number on the MSBNPE website at earliest.
