NOTIFICATION

MAHARASHTRA UNAIDED PRIVATE PROFESSIONAL EDUCATIONAL INSTITUTIONS (REGULATION OF ADMISSIONS AND FEES) ACT, 2015

No. NUR.2018/C.R.145/18/Education-1 – Whereas, in exercise of the powers conferred by clause (r) of section 2 read with sub-sections (1) and (2) of section 3 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015), the Government of Maharashtra has, vide the Government Notification, Higher and Technical Education Department, Notification No. MISC-2015/C.R.252/TE-4, dated the 3rd December 2015, published in the *Maharashtra Government Gazette*, part IV-B, Extraordinary, dated the 3rd December 2015, declared and notified the educational courses and studies of the Medical Education Department as the Professional Education for the purpose of the said Act;

And whereas, the Government of Maharashtra has, vide the Government Notification No. MED.1015/CR.342/15 Education -2, dated the 21st June 2016, made amendments to the said Notification and added entry No 25, 26 and 27;

And whereas, it is expedient to amend the said notification; Now, therefore, in exercise of the powers conferred by clause (r) of section 2 read with sub-sections (1) and (2) of section 3 of the said Act, the Government of Maharashtra hereby makes the following amendments in the Schedule appended to the said Notification :-

After entry 27, the following entries shall be added, namely,-

Serial No. (1)	Professional Education (2)	Eligibility conditions and requirements for admissions (3)
“28.	1st year of General Nursing and Midwifery (GNM).	•10+2 class passed preferably Science (PCB) & English with aggregate of 40% marks <i>or</i> •10+2 in Arts (Mathematics, Biotechnology, Economics, political Science, History, Geography, Business Studies, Accountancy, Home Science, Sociology, Psychology, Philosophy) and English core/English Elective or Health

care Science - Vocational stream ONLY, passing out from recognized Board under AISSCE/CBSE/ICSE/SSCE/HSCE or other equivalent Board with 40% marks *or*

- 10+2 vocational ANM under CBSE Board or other equivalent board with 40% marks *or*
- Registered as ANM with state Nursing Registration Council *or*
- As prescribed by the Indian Nursing Council, from time to time.

29. 1st year of Auxiliary Nurse and Midwife (ANM).

- The minimum educational requirements shall be 10+2 in Arts (Mathematics, Physics, Chemistry, Biology, Biotechnology, Economics, Political Science, History, Geography, Business Studies, Accountancy, Home Science, Sociology, Psychology, Philosophy) and English core/English Elective or Science or Health care Science - Vocational stream ONLY passing out from recognized Board *or*
- As prescribed by the Indian Nursing Council, from time to time.”
